- 1. <u>Situation</u>. The Service members of U.S. Marine Corps Forces, Japan (MARFORJ) are part of the Nation's only forward-deployed Marine Expeditionary Force, or they man the Advanced Naval Bases that underwrite every operation or activity. MARFORJ personnel can enjoy everything Japan has to offer while also conducting liberty and leave in a manner that brings credit to MARFORJ, the Naval Service, and the United States. Professional and responsible conduct on liberty reinforces to friends and adversaries alike that the Service members of MARFORJ are disciplined, reliable, ready, and take care of each other. Misconduct negatively impacts readiness, how friends and adversaries view MARFORJ, and erodes support among local populations and governments at a critical time. This Order codifies expectations for the conduct of liberty in a safe and proper manner in the MARFORJ Area of Operations and is punitive in nature.
- 2. Cancellation. MARFORJO 1050.1C w/ Admin Ch 1 of 13 March 2024.
- 3. <u>Mission</u>. MARFORJ personnel execute liberty in a safe and responsible manner protecting the force and civilian population, enhancing morale and welfare, reinforcing the vital relationship with our Japanese hosts, and upholding our obligations under the Treaty of Mutual Cooperation and Security.

4. Execution

- a. <u>Commander's Intent</u>. The expectations of our forward-deployed MARFORJ Team remain high. We are actively campaigning and competing, a long way from home, in a strategically critical region. Because the Service members of MARFORJ continue to work hard in a pressurized setting every day, leave and liberty remain critical to morale, readiness, and lifebalance. At all times, both on and off duty, members of MARFORJ will conduct themselves as disciplined, competent, and accountable professionals on and off duty. Individual Service members are accountable for their personal conduct. Liberty is enjoyed or lost based on personal conduct. Commanders and leaders at every level are responsible for briefing and making sure every member of their unit is fully knowledgeable of all applicable liberty regulations to set their Service members up for success on liberty while holding those accountable who do not meet the standard. Successful liberty execution requires thorough planning, supervision, and accountability.
- b. <u>Endstate</u>. The maximum number of MARFORJ Service members enjoy liberty responsibly, safely, and in a manner that brings credit to the Naval Service and Nation while respecting local laws, regulations, and customs.
- c. <u>Concept of Operations</u>. Personnel will execute liberty in Japan in accordance with this Order.
- (1) Required Training. In accordance with reference (b), Commanders who authorize liberty shall ensure all personnel are briefed on current security conditions and other relevant issues pertaining to the given liberty area. Commanders will also ensure Service members understand their responsibilities under the Status of Forces Agreement (SOFA) for all interactions with Japanese police. In addition, prior to authorizing liberty, commanding officers shall ensure personnel have received the following training in accordance with Service regulations/instructions and Department of Defense directives/instructions prior to being granted off-base liberty in Japan:
 - (a) Sexual Assault Prevention and Response training;
 - (b) Training on service regulations prohibiting fraternization;
 - (c) Training on DoD policies regarding Trafficking in Persons;
- (d) Training on restricted activities with firearms and other weapons outside of USFJ Installations; and,
- (e) Training on required standards for driving outside of USFJ installations, including penalties for driving under the influence.
- (f) Training on off-limits areas and establishments as defined by references (f) and (k); and
- (g) Training on cultural awareness, and other relevant issues pertaining to the given liberty area.

- (2) <u>Curfew</u>. Curfew remains age-based. All MARFORJ personnel aged 19 and below must be in one of the following locations between 0100 and 0500:
 - (a) on a U.S. military installation;
 - (b) in a private, off-installation residence;
 - (c) in a temporary lodging location/hotel;
- (d) transiting directly between an airport and a U.S. military installation, a private offbase residence, or a place of temporary lodging (hotel) due to transit needed to execute or terminate leave within four hours of flight; or
 - (e) or in the performance of official duties (including duty-related travel).
- (3) <u>Curfew Exceptions to Policy</u>. On a case-by-case basis, Commanders are authorized to make written exceptions to the curfew hours requirement for a designated period. This authority may be delegated in writing to the first officer with non-judicial punishment authority within the MARFORJ Service member's chain of command.
- (4) <u>Individual Liberty Levels</u>. All MARFORJ personnel are assigned to Tier 1 liberty status as defined in paragraph (d) below unless the commander determines a more restrictive tier is necessary. Commanders may assign Service members within their command to different liberty tier levels based on individual merit, demonstrated personal conduct, and trustworthiness without administrative action or legal review; however, the specific performance and/or conduct basis for a liberty tier reduction will be detailed in writing. If not otherwise required, commanders may specifically direct a requirement for a liberty buddy on a case-by-case basis. Pursuant to paragraph 0104.b. of reference (a), nothing in this order limits a commander's authority to place more restrictive measures on an individual Service member's normal liberty for nonpunitive purposes, on a case-by-case basis, to protect foreign relations. Commanders should consult with their unit Staff Judge Advocate before the implementation of more restrictive measures or as soon as practicable after implementation.
- (a) <u>Tier Cards</u>. Commanders will issue all E-5 and below Service members a Tier 1, 2, or 3 liberty card from the enclosure that personnel must carry while on liberty. Service members must show their liberty card and DoD ID card to a command representative if directed to do so. Officers and SNCOs will not carry Tier 1 liberty cards, but are required to show their DoD ID card if directed by a command representative. Any SNCO or officer assigned to Tier 2 or Tier 3 Liberty Status will be issued a Tier 2 or Tier 3 liberty card, must carry it while on liberty, and are required to show their tier card if directed by a command representative.
- (b) <u>Tier 3 Liberty</u>. A commander may assign any Service member within their command to a Tier 3 Liberty status. Personnel in a Tier 3 liberty status are prohibited from off-installation liberty, may not consume alcohol anywhere, and must remain on their home installation from 2200-0500. Personnel authorized to live off-installation assigned to a Tier 3 status may only conduct liberty activities on-installation, and must remain in their residence from 2200-0500.

- (c) <u>Tier 2 Liberty</u>. A commander may assign any Service member to a Tier 2 Liberty status. Tier 2 liberty personnel may not purchase or consume alcohol off-base unless the alcohol is consumed in the Service members assigned off-base quarters. These personnel may consume alcohol aboard military installations but must remain on their home installation from 2300-0500.
- (d) <u>Tier 1 Liberty</u>. Except as noted in paragraph 4.c.(2), MARFORJ personnel in a Tier 1 liberty status do not have an off-base curfew; however, no MARFORJ personnel, regardless of age or rank, are authorized to be in an off-base drinking establishment between 0100 and 0500. Off-base alcohol consumption is also prohibited for all personnel, regardless of rank, between 0100 and 0500 unless in a personal residence or hotel room.
- (e) <u>Additional Tier Guidance</u>. Off-base liberty is an important component to morale and welfare; therefore, before increasing a Service member's tier status, commanders should carefully consider whether the Marine's prior conduct increases their risk for committing off-base misconduct that may jeopardize our alliance and long-term presence in Japan. Tiered liberty is a nonpunitive tool commanders can use to protect foreign relations. Commanders should only increase Tier status when the individual Service member's conduct, or lack of trustworthiness creates a foreseeable risk that the Service member's conduct could negatively impact host nation relations if allowed to remain at a lower Tier level.
- 1. Ordinarily, Commanders should not apply an increased Tier status on a unit basis unless compelling circumstances justify such action. Commanders must exercise good judgment, tactical patience, and sound reasoning. The examples of compelling circumstances listed below are illustrative, not all inclusive, and not intended to be proscriptive: (1) a rising trend of misconduct indicating a breakdown of good order and discipline at the unit level; (2) major incidents of misconduct committed by multiple members of the unit acting together; or (3) multiple incidents of serious misconduct in rapid succession.
- <u>2.</u> Commanders shall not apply an increased Tier status to an entire unit as collective punishment for minor misconduct committed by individuals. Any unit level assignment must be justified in writing and predicated specifically on protecting foreign relations.
- <u>3.</u> Service members in a higher Tier status are not on restriction, and therefore should not be required to check in or out with a duty.
- 4. Commanders may post a SNCO or officer at base gates after hours to enforce this Order by inspecting tier cards.
- <u>5.</u> At a minimum, every 30 days, commanders will review the Tier 3 and Tier 2 status assignments and provide Service members with the written rationale for continued assignment, as well as the opportunity to provide a written petition to the commander for reconsideration as a result of Tier 3 or Tier 2 status assignment or continuation of assignment.

(5) Liberty Buddy Program

- (a) All MARFORJ Service members in the grade of E-4 and below are required to always have a liberty buddy while off-installation on leave or liberty when consuming alcohol. A liberty buddy may be:
- 1. Active-duty Service members, from any armed force, serving in Japan under the SOFA;
- <u>2.</u> Non-military adults with SOFA status (e.g., command-sponsored spouse, accompanied family member, or U.S. Department of Defense civilian employee);
- <u>3.</u> Other adult family members (e.g., visiting relatives, non-SOFA spouse, local national spouse/fiancé, extended family).
- (b) On a case-by-case basis, commanders at the O-5 level are authorized to make written exceptions to the requirement for a liberty buddy for a designated period. This authority may be delegated in writing to the first officer with non-judicial punishment authority within the MARFORJ Service member's chain of command. Liberty buddies are not required in the performance of official duties.
- (c) Once either liberty buddy has begun consuming alcohol, liberty buddies will remain within the immediate vicinity of each other at all times until the Service members return to their home installation, off-base residence, or temporary lodging location. MARFORJ members take care of one another and should make every reasonable effort to prevent inappropriate or illegal activities by other Service members.
- (d) Travel to international locations outside Japan may require a buddy if directed by the Foreign Clearance Guide (https://www.fcg.pentagon.mil/fcg.cfm), Department of State (https://travel.state.gov/content/travel.html), higher headquarters, or geographic combatant commander travel requirements.
- (6) <u>Alcohol</u>. Excessive alcohol consumption is the most common factor in misconduct cases; Service members will consume alcohol in a safe and responsible manner.
- (a) Alcohol Consumption in Japan. Service members 20 and over may legally consume alcohol in Japan unless assigned to a Tier level prohibiting this activity, or when under TCCOR status as noted in paragraph 4c(6)(c). In Japan, driving with a blood alcohol content (BAC) of .03 percent or greater violates Japanese law. Reference (c) and this Order also prohibit any person subject to these orders from operating or being in physical control of any vehicle while intoxicated, or while under the influence of alcohol or any other intoxicant, including intoxicating beverages, drugs, or any combination thereof. Violations of this provision are presumed if a person's blood alcohol content (BAC) is 0.03 percent by mass of alcohol per volume of blood or more. Alcohol-related misconduct, especially driving under the influence or while intoxicated, may result in curtailed or restricted liberty, revocation of driving privileges, administrative or disciplinary action under reference (d), as well as legal action under Japanese law. Japanese law further prohibits enabling driving under the influence; passengers of drivers operating under the influence may also face criminal liability.

(b) Public Consumption of Alcohol

- 1. While on an installation, no person will possess or consume alcoholic beverages in any public or working area, except within authorized U.S. Forces clubs, messes, exchange facilities, or common areas such as pavilion or BBQ areas. Camp Commanders may authorize the consumption of alcoholic beverages in other areas during installation spectator type events, public gatherings, assemblies, or unit functions on a case-by-case basis.
- <u>2.</u> Whether a driver or a passenger, alcohol will not be consumed in a vehicle. This Order also prohibits open containers of alcohol in a vehicle, except when transporting to another location for consumption and stored out of the occupant's reach.
- 3. All military personnel, regardless of age, are prohibited from being physically present in an off-base drinking establishment between 0100 and 0500 (on all days, including holidays). Off-base alcohol consumption is also prohibited for all personnel, regardless of rank, between 0100 and 0500 unless in a personal residence or hotel room. A drinking establishment is defined as any business whose primary function is serving alcoholic beverages for consumption on the premises. A drinking establishment may serve food or have other forms of entertainment, but its main purpose is to serve alcoholic beverages. Drinking establishments may include, but are not limited to, bars, pubs, taverns, nightclubs, karaoke venues, and izakayas.
- (c) <u>Alcohol Consumption During Typhoon Cyclone Condition of Readiness (TCCOR)</u> <u>Categories</u>. This Order prohibits MARFORJ personnel from consuming alcohol during the following TCCOR categories: TCCOR One, TCCOR One Caution, TCCOR One Emergency, TCCOR One Recovery, and Storm Watch. Personnel may only consume alcohol when the TCCOR level is set to "All Clear" or the member's command permits regular liberty. Alcohol consumption restrictions are subject to local TCCOR categories.
- (7) Regular and Special Liberty. Regular liberty begins at the end of the workday and expires at the commencement of the following workday. Service members are considered within the vicinity of their PDS while in regular liberty boundaries. On weekdays, Service members stationed on Okinawa will not leave the Okinawa Prefecture; Service members stationed on mainland Japan will not leave mainland Japan. As required, MARFORJ personnel will submit special liberty requests to their commanding officer via the chain of command for approval. Commanders may grant personnel in a Tier 1 or Tier 2 liberty status special liberty on a case-bycase basis. Special liberty will not exceed four days and is subject to off-limits area restrictions, liberty buddy requirements, and curfew parameters. Commanders may delegate the authority to approve special liberty within a regular liberty period to executive officers and section officers-in-charge (O-4/GS-13 or above). The commanding officer may authorize special liberty for specified periods, which include normal working hours and/or overnight hours, subject to the following limitations:
- (a) <u>48-Hour Liberty</u>. 48-hour liberty includes regular weekend liberty and special liberty granted by the commander. The commander may grant 48-hour special liberty commencing at any hour the commander designates. The liberty limits for 48-hour special liberty are the same as regular weekend liberty and authorizes liberty on all Okinawan islands and mainland Japan for MARFORJ personnel.

- (b) <u>72-Hour Liberty</u>. 72-hour liberty includes authorized holiday liberty periods and special liberty granted by the commander. 72-hour special liberty may commence at any hour the commander designates and expires 72 hours later. When a three-day liberty period includes only regular liberty time, with no scheduled working hours included, it is then treated as regular liberty. The liberty limits for any 72-hour liberty includes locations authorized within the 48-hour liberty limits, as well as the Republic of Korea (South Korea), Taiwan, and Guam.
- (c) <u>96-hour Liberty</u>. 96-hour liberty includes authorized holiday liberty periods and special liberty granted by the commander. 96-hour special liberty may commence at any hour the commander designates and expires 96 hours later. The liberty limits for any 96-hour liberty period includes locations in the 72-hour liberty limits as well as liberty in Cambodia, Indonesia, Laos, Malaysia, the Philippines, Singapore, Thailand, Vietnam, and Palau.
- (d) <u>Geographical Limitation</u>. Reference (m) authorizes personnel to take leave in conjunction with liberty without a duty day in between the periods of absence. This authorization is subject to a geographic limitation that all leave begin and end in the vicinity of the Service member's Permanent Duty Station (PDS) or worksite, as defined by the boundaries within the local leave policy. A Service member's PDS or worksite is defined as Okinawa Prefecture for Service members stationed on Okinawa and mainland Japan for Service members stationed on mainland Japan.
- (e) <u>Foreign Travel Outside of Japan</u>. Any Service member intending to travel to foreign countries outside of Japan during liberty must comply with the following requirements:
- 1. Obtain travel information and comply with the laws of countries visited. Many countries in the Pacific require special approval to visit. The most up-to-date travel requirements are found in the Electronic Foreign Clearance Guide, at: https://www.fcg.pentagon.mil/fcg.cfm. If required, personnel must also complete Anti-Terrorism Force Protection briefs before the commander will approve the request.
- $\underline{2}$. Personnel must have current immunizations, including those required for the country they are visiting.
- 3. Personnel should not rely on space available travel using Air Mobility Command (AMC) flights during special liberty periods. SOFA personnel attempting to travel using AMC must have sufficient funds to defray travel expenses, including for hotel accommodations, when AMC flights are delayed or unobtainable.
- 4. Travelers must comply with published U.S. Indo-Pacific Command (USINDOPACOM) travel requirements (ATP/Travel Tracker and APACS submissions, etc.) and register with the U.S. Department of State prior to traveling to a foreign country outside of Japan.
- (8) Off-Limits Areas and Establishments. Reference (f) lists areas and establishments off-limits to MARFORJ personnel. Reference (k) is a consolidated listing of off-limits establishments across USFJ; this order incorporates reference (k) as enforceable, and in the event of a conflict with Reference (f), the more restrictive list controls.

- (9) <u>Appropriate Civilian Attire</u>. Reference (g) outlines proper civilian attire required. This Order is not intended to conflict or supersede reference (g); however, MARFORJ personnel are in a unique position to represent the United States, Department of Defense, and Naval Services while in a foreign country. As such, it is important to display a conservative and neat outward appearance to reflect credit upon our country and Service. All articles of clothing will be clean and serviceable and present a neat outward appearance. Below are general guidelines for wearing civilian attire on liberty.
- (a) <u>Footwear</u>. Personnel will wear appropriate, serviceable footwear. Sandals are authorized, but shower shoes and bare feet are not appropriate for liberty attire unless executing liberty at swimming pools or recreational beaches.
- (b) <u>Shirts and Blouses</u>. Personnel may wear shirts and blouses untucked, provided they do not hang below crotch-level. Shirts and blouses not tucked in, such as Hawaiian style shirts, must reflect a neat appearance and not be excessively baggy. Uniform and civilian undershirts are not appropriate as outerwear, unless participating in sports or physical training activities.
- (c) <u>Trousers, Shorts, and Skirts</u>. Excessively oversized trousers, shorts, and skirts, or those that expose any portion of the buttocks or underwear are inappropriate. Personnel should wear properly hemmed and fitted shorts and skirts that maintain proper modesty and are not unacceptably revealing.
- (d) <u>Inappropriate Civilian Attire</u>. This Order prohibits wearing altered or cut clothing or clothing worn in a manner to present an abbreviated covering or sexually provocative appearance. This Order also prohibits personnel from wearing clothing that a reasonable person may interpret as profane, derogatory towards any group or nation, sexually suggestive, or obscene. Tattered or soiled clothing is not appropriate for civilian wear. Personnel will not wear athletic attire in mess halls, retail stores, the Base Exchange, Post Exchange, commissary, base theaters, clubs, or restaurants.
- (e) <u>Liberty Attire while Traveling on Official (funded) Travel</u>. All personnel on official (funded) travel must be mindful of their attire while traveling. In Japan, it is customary for host nation personnel to wear formal business attire, such as suits and ties for men, and smart, conservative outfits for women. As representatives of the United States abroad, dressing appropriately reflects positively on the individual and fosters goodwill and cultural respect. MARFORJ personnel will wear business casual attire while on funded official travel. Appropriate and recommended travel attire includes slacks and a collared shirt. Jeans that meet the requirements set forth in reference (g) and para 9 (c) are acceptable. Sweatpants and shorts are not authorized for funded official travel.
- (10) If Service members are aware of misconduct, they must directly report the information to their chain of command or other appropriate organization/office as soon as possible in compliance with Article 1137 of reference (1).

d. Coordinating Instructions

- (1) This Order applies to all military personnel located and operating in Japan who are subject to MARFORJ authority, including Reserve personnel (when serving in a Reserve capacity), National Guard personnel (when in a Title 10 status), and personnel in a TDY/TAD, deployed, leave, or pass status.
- (2) This Order is punitive in nature. Violations of this order are punishable under Article 92 of reference (d) and may subject violators to punitive or adverse administrative action. Violations of this Order may also violate Japanese law and subject offenders to prosecution by Japanese authorities.
- (3) Commanders, defined as those officers in the grade of 0-5 or above and possessing command authority over Service members, are authorized to establish more-restrictive liberty programs consistent with this Order to maintain readiness, safeguard the force, and protect relations between the United States and Japan.
- (4) Command representative, as used in this order, refers to any SNCO, officer, or other command representative in the official conduct of their duties (i.e. courtesy patrol, installation gate security, etc.), regardless of Service or rank.
- (5) Per reference (h), courtesy patrols will operate on Fridays, Saturdays and during holiday liberty periods from 2200-0200. Courtesy Patrols will normally consist of four to six uniformed members patrolling areas SOFA members frequent during liberty periods.
- (6) If disparity exists between this Order and other properly promulgated Orders, regulations, laws, or policies, the more restrictive rules shall apply.

5. Administration and Logistics

- a. <u>Publication</u>. MARFORJ subordinate commanders will publish this Order to Service members assigned or attached to their commands.
- b. Reporting Liberty Incidents Involving Allegation of Sexual Assault. Commanders of subordinate units of MARFORJ will make timely notification to Commander MARFORJ, t using established reporting requirements. For all alleged sexual misconduct incidents involving a non-SOFA individual, Commanders shall send prompt certification of the Servicemember's compliance with training requirements through their respective Staff Judge Advocate office to HQ USFJ (ATTN: J06) via MARFORJ SJA. This certification will be made no lower than the first commissioned officer exercising court-martial convening authority over the Servicemember.

6. Command and Signal

a. <u>Command</u>. This Order applies to all U.S. military personnel assigned to, attached to, or under tactical or administrative control of the Commander, MARFORJ authority, including Reserve personnel (when serving in a Reserve capacity), National Guard personnel (when in a Title 10 status), and personnel in a TDY/TAD, deployed, leave, or pass status while in Japan.

b. Signal
